02. HONOURIUM ON RETIREMENT TO OUR MEMBERS RS.1,000/-

- a) Who are retired on or after 1st December 2014
- b) The amount of honourium will be the same to all the cadre.
- c) He will be our Association member, his/her retirement in normal course, and subscription will be regular up to his retirement.
- d) He submit a simple application in writing along with letter issued by the Bank at the time of his retirement to the General Secretary SBH OBC Employees Welfare Association, Head Office Hyderabad

03. MONTHLY SUBSCRIPTION ENHANCED.

Officer	-	Rs.55/-
Clerical	-	Rs.30/-
Substaff	-	Rs.20/-




