Dear Comrade,

Consequent to the acquisition of Five Associate Banks by State Bank of India, the All India State Bank Officers Federation to which Associate Banks' Officers' Association is affiliated has entered into an MOU with ABOA to merge its members with its respective Circle Associations of SBI Officers' Associations wherever ABOA membership is geographically placed. In view of the creation of SBI, Telengana Circle and Amaravathi Administrative and Business Unit by SBI in the erstwhile AP, it has been decided that the State Bank of India Officers Association (Hyderabad Circle) will continue to function as a single entity to look after the affairs of the Officers in both the Circles till such time the creation of new SBIOA (Amaravathi Circle) and Elections to its Executive Committee, or February 2018 coinciding with the existing term of the SBIOA(Hyderabad Circle), whichever is earlier.

Further, it was unanimously resolved in the Extra Ordinary Central Council Meeting of ABOA held at Hyderabad on the 27th & 28th May, 2017, to dissolve the ABOA. Consequently, in accordance with the terms of the MOU entered into between ABOA and AISBOF, the funds of the Units of ABOA shall be transferred to respective SBI Circle Associations as per the geographical location, proportionately if the members are more than 100 in number in a Circle. As far as the Fixed Assets owned by ABOA are concerned, they will be transferred to respective SBI Circle Associations wherever the properties are located.

The modalities to be followed for utilising the funds lying in The Benevolent Fund of e-SBH Officers, are on the verge of finalisation by mutual consensus of e-ABOA (Unit: SBH) and SBIOA(HC) and the details will be circularised in due course.

As per the understandings, the following Office Bearers of ABOA, Unit: SBH have been co-opted as Office Bearers in the SBIOA (Hyderabad Circle) till next elections or February, 2018, whichever earlier:-


