Shri. M Rajendra Prasad, President said thanks to DGM for holding meeting in a crucial period in the month of March as, it is very busy month for the controllers, since they have to concentrate totally not only for achieving their budgeted goals but also have to concentrate on reduction of NPAs. He also assured the DGM, we will advise our membership to work for business development of the bank and also reducing the NPAs considerably.

The General Secretary Shri. D B Kalashetty said thanks to DGM for conducting meeting, it is mandatory to conduct half yearly meeting as per Government guideline within span of a half yearly intervals, even there is no agenda items/grievances.

He assured to DGM, whenever we attend meetings, we are advising our membership to work hard for development of bank business. He informed that more than 5000 members working in the bank around 500 OBCs staff members are working in the zone, it is one of the largest OBC members working in a zone of our Bank.

Further, he informed that the SBH management provided the office accommodation to our welfare association at Head Office, the furniture work going on, after completion, we will hold opening ceremony by notified personality/politician. The UPA Government also formed Parliamentary Committee for OBCs consisting of 20 MPs and 10 Rajyasabha members.

02. DGM agreed whenever liaison officer changes circular will be issued.
03. Proportionate posting of OBCs Officers/Employees at ZO/RO will take care at the time of annual transfer exercise.
04. DGM agreed to extend official invitations to Office bearers for the official functions in the zone for official functions.
05. The half yearly meetings will be conducted as per scheduled.
06. Introduced the grievances register at Zonal/Regional Office/Branches.
07. Discussion held on the relief of the clerical staff, who is under transfer including sub-staff. Some of the branches not extending single window allowances to the newly recruiters, even though working in cash counter. DGM agrees as per circular, advising the branches to extend the same who are working on SWO counter.


The Vote of thanks proposed by Shri. Ramakrishna rao, Asst. General Manager, Region-I, Zonal Office, Hyderabad..
