

GENEAL SECRETARY REPORT

The Annual General Body Meeting of the State Bank of India OBCs Employees' Welfare Association, Hyderabad Circle held on the 28th August 2022 at 11.00am at Prabhat Towers, Parwana Hall, 4th Floor, Gunfoundry Hyderabad.

My dear members,

I have immense pleasure in welcoming you all to Annual General Body Meeting of our mighty Welfare Association being held today at Hyderabad, I place this report before you.

Before proceeding further, it is our duty to pay respects to the departed souls of persons of eminence our colleagues and others who lost their lives, let us pay our respectful homage to the departed souls by observing two minutes silence. May their souls rest in Peace.

The SBH merged with SBI on 1st April 2017 since then SBI Management stopped all benefits extended by eSBH like Half Yearly Meetings, Check off facility, Pre-promotion Training, one day Work shop for our representatives along with Liaison officers saying that there is no SBI OBC Welfare Association existing in the SBI.

After merger we have modified the name of our Welfare Association as SBI OBC Employees Welfare Association Telangana/Andhra Pradesh Circle on 9th May 2017 and registered with Registrar of Societies, Hyderabad and submitted same to SBI Local management Hyderabad Circle. After some time SBI Management created another Circle for Andhra Pradesh i.e Amaravati circle. Hyderabad Circle Management asked us to rename and submit new registration certificate, we have modified Bye-Laws and renamed the Association as SBI OBC Employees Welfare Association Hyderabad Circle on 25th October 2018 and submitted to Local Management.

Since April 2017 many quires/points/clarifications are raised by Local Management, we have replied/submitted/clarified all points but lastly, they put one condition that should have minimum membership of 35% entire Circle membership, against this we have contested and follow up with Ministry of Finance (DFS) they also that clarified no need not be 35% of granting of Welfare Associations in the Bank, then after the SBI management also not recognized, we once again approached/continuous follow-up with all Government Agencies like Ministry of Finance (DFS), National Commission for OBC and the Parliamentary Committee for OBC. Our continuous efforts/follow-up, lastly NCBC organizes a day hearing on the 10th February 2022 at NCBC Chairperson Chamber, in the hearing Bank Top Management Representatives and our Associations representatives are present, on the day representatives of Bank Management requested to the NCBC Chairperson give us 90days time for frame policy and guideline to grant recognition to the Welfare Associations in the Bank, the Chairperson agreed and granted, he put the ultimatum 90 days to frame policy/guidelines and get approval by the Central Board of the Bank. After 90 day Bank has released Standard of Procedure (SOP) certain conditions/guidelines. We are now compiling/replying to local management.

Hence, our continuous follow up with the members, now we have collected 1000 membership forms, hence, I request you all please mobilize among the members and enroll the membership along with you on urgent basis, then only local management recognize the our Welfare Association in Hyderabad Circle.

02. Nominating OBC members in all internal promotion interview committee for all promotions. Since our members are not getting due justice in promotions.
03. Nominating OBCs representatives in the Local Head Office Welfare Committee.
04. Provide pre-promotional training for promotions from Clerical to Officer Cadre.
05. Four i.e. quarterly meetings in a year at Local Head Office/AOs/ RBOs
06. Inspection of Rosters.
07. Up gradation of Liaison Officer's post to Asst. General Manager at AOs
08. Extension of Official invitation to OBC Welfare association's Representatives
09. Deputation of OBC Employees Welfare Association representatives to Training/ Workshop conducted by outside agencies on various topics connected with
10. OBC Welfare Association's representatives should be involved in transfer exercise.
11. 27% reservations to OBCs employees/Officers in promotion of all scales.
12. Office accommodation at LHO/AOs to our Welfare Association
13. Restoration of Structured Meetings at RBOs.
14. Conducting Annual Meetings at Ministry level with OBC Welfare Associations and Management
15. Removal of creamy layer.
16. Our representation on the Bank's Board (Director) as in case of Trade Unions.
17. Posting of our Zonal Vice Presidents/Dy. General Secretary at AOs/RBOs, Offices.

21. Implementation of Nachippan Committee Recommendations.


